PARTICIPATION CONSENT & RELEASE FROM LIABILITY

As parent/guardian of the herein named minor child _____, I grant my permission for him/her to participate in Marine Corps Community Services (MCCS) events 2018 Spring MCRD JR SOCKERS LEAGUE at MCRD. (Herein after referred to as the "Event"), to be held at Marine Corps Recruiting Depot, San Diego, California (MCRD) September 8 – October 20, 2018. In consideration for the Child's participation in the Event, I hereby take the following actions for myself, the Child, my executors, administrators, heirs, next of kin, successors and assigns, or anyone else who might claim or sue on my behalf:

(a) I acknowledge that the Event will include several athletic activities, including, but not limited to the following: water and swimming; general recreation; and sports. The Event will also include transportation by motor vehicle. I understand that the Event will take place at various venues both at MCRD and off the installation.

(b) I certify as follows: (1) that the Child is properly equipped for the Event, including equipment required by Event rules, and will at no time participate in the Event without it; (2) that the Child is physically fit and able to participate in the Event; has reported all unusual medical conditions to MCCS; and (3) that the Child has not been advised against participation in the Event by a qualified health professional.

(c) I acknowledge as follows: (1) that I have read and understand all applicable Event Rules and agree that the Child will abide by them; (2) that the Child will obey all posted Event safety signs and will obey instruction of Event instructors while participating in the event; (3) that the Child will follow safe procedures and to avoid unnecessary hazardous situations; and (4) that the Child has received the instruction from Event instructor personnel necessary to participate in the event safely.

(d) I agree that, prior to the Child's participation in the Event, I will inspect the motor vehicles, facilities, equipment, and areas to be used and, if I believe any are unsafe, I will immediately advise a person supervising the event;

(e) I acknowledge that some of the Event activities are arduous tests of the Child's physical limits and carry with it the potential for drowning, death, serious injury, and property loss;

(f) I acknowledge that there will be numerous participants in the Event and that their actions may be unpredictable;

(g) I assume all risks associated with the Event, including, but not limited to, falls, contact with other participants, effects of weather, defective equipment, water conditions, the Child's personal physical condition; lack of hydration and traffic accidents

(h) In connection with the Event, I forever release, acquit and discharge from all known obligations, losses, damages, liabilities, injuries, claims, demands, actions, causes of action and expenses, the following persons

or entities: United States Government; the United States Marine Corps, MCCA, and the employees, representatives and agents of the above;

(i) In connection with the Event, I agree not to sue any of the persons or entities mentioned in paragraph (h) above for any of the claims, losses or liabilities that I have waived released and discharged therein;

(j) In connection with the Event, I indemnify and hold harmless the persons or entities mentioned above in paragraph (h) above from any and all claims made or liabilities assessed against them as a result of the Child's actions or inactions during the Event

(k) In connection with the Event, I hereby authorize emergency medical treatment for the Child in the event of injury or illness; I also authorize trained health care providers, including, but not limited to, physicians, nurses, nurse practitioners, and hospital corpsmen to administer routine and emergency medicines and treatments to the Child as needed.

(l) In connection with the Event, I grant permission to MCCA to use the Child's name and likeness relating to the Child's participation in the Event and waive all rights to any compensation to which the Child may be entitled as a result of such use.

I hereby certify that, as parent or guardian of the Child, I have legal responsibility for and authority to sign this Participation Consent & Release from Liability on behalf of the Child.
